In consideration of being permitted to utilize the New Carrollton Dog Park facilities, Releasor, for himself or herself; his or her spouse; legal representatives; heirs and assigns hereby releases, waives and discharges the City of New Carrollton, Maryland, a body of politic and corporate in the State of Maryland, its officers, agents and employees and each of them referred to as Releasee's from all liability to the Releasor, his or her spouse, legal representatives; heirs and assigns for any and all loss or damage; claims or damages (including attorney's fees) resulting from Releasor's use of the New Carrollton Dog Park on account of injury to Releasor or his/her dog or other pet utilizing the New Carrollton Dog Park, or injury to Releasor or his/her pet or property whether caused by negligence of Releasees or other persons utilizing the New Carrollton Dog Park (or their respective dogs or pets).

Releasor further agrees to indemnify and hold harmless the Releasees from any and all loss liability; damage; cost or the like (including attorney's fees) Releasees may incur as a result of the Releasor's use of the New Carrollton Dog Park or any negligence by Releasor in Releasor's use of the New Carrollton Dog Park.

Releasor expressly agrees that this release, waiver and indemnity agreement is intended to be a broad and as permitted by the laws of the State of Maryland.

RULES AND REGULATIONS

1. The dog park is for the use and enjoyment of permit holders only
2. Permits are available to City of New Carrollton Residents and Residents of Prince Georges County
3. The fee for permits is \$10 to City of New Carrollton Residents and \$30 for Prince Georges County Residents
4. Dogs at the park must be wearing up-to-date rabies vaccination tags, and permit tags at all times
5. Owners are legally responsible for their dogs and any injuries caused by their dogs
6. Dog owners must remain with their dogs in the exercise area, and must keep their dog in sight at all times
7. Dog owners must carry a leash
8. Dogs showing aggressiveness toward people or other dogs must be immediately leashed and removed from the dog park
9. Dogs in heat are not allowed in the dog park
10. Puppies using the dog park must be older than four (4) months
11. Owners must clean up and dispose of feces deposited by their dogs immediately, Take one bag per dropping
12. Owners must stop their dogs from digging. Any holes created by your dogs must be filled.
13. The dog park exercise area is for the use and enjoyment of dogs and their owners. Recreational use by others is not permitted
14. No smoking or eating while in the exercise area
15. Violators of rules for use of the park are subject to removal from the park, suspension or revocation of dog park permits, and the issuance of municipal infractions
16. Professional dog trainers may not use this facility in the conduct of their business
17. Park hours are from dawn to dusk
18. Children under 6 years old are not allowed in the park, children over 6 years old must be accompanied by an adult
19. Due to Prince Georges County Law, no pit-bulls are allowed in the dog park
20. Owners are responsible for the discipline and restraint of their own dogs, taking physical action against another person's dog is prohibited by law and will warrant immediate removal from the park
